# Letter from the President

## Dear Holy Cross Family,



**A**s we collect data and stories for the 2017-2018 Annual Report, it is an opportunity to reflect upon all of the wonderful and exciting successes of the past year. In my first year as President of Holy Cross High School, I am amazed by all of the faculty, alumni, businesses, families,

community leaders, and team members who work to make Catholic Education possible in Southwest Louisville. It is truly a labor of love and pride that we continue to beat the odds and to provide a 21<sup>st</sup> century, progressive education rooted in a deep sense of Catholic Identity to families in the Dixie corridor. My tenure as president began in July of 2017 with a wonderful Installation Mass presided by Archbishop Kurtz in which we prayed for the continued success of Holy Cross and for God's continued guidance upon our leadership. **W**orking in my first year as principal, and my 20<sup>th</sup> year in education, I couldn't be happier to be a part of Holy Cross. # Have You Considered?

**H**ave you considered giving the gift of appreciated stock? Often times charitable giving and tax planning go hand in hand. When appreciated stock is sold, the profit is typically taxed at the prevailing capital gains tax rate. Alternatively, when donating appreciated stock, the Internal Revenue Service in most instances permits the full donated value of the stock to be claimed as a charitable donation. The income tax savings through a gift of stock can be significant, as depicted in the following examples.

Stock Name .....	Computers INC.
Original Purchase Amount .....	\$10,000
Current Market Value .....	\$25,000
(eligible for charitable deduction)	
Appreciated Increase .....	\$15,000
(subject to capital gains tax if sold)	
Income Tax Savings if Stock is Gifted.....	\$8,500 (estimated 34%)
Or	
Capital Gains Tax Due if Stock is Sold .....	\$3,900 (estimated 26%)

If your year-end tax planning includes charitable giving considerations, donating appreciated stock may be an excellent opportunity to increase the level of giving. As always we encourage our donors to consult with a qualified tax professional to determine tax savings for specific circumstances.

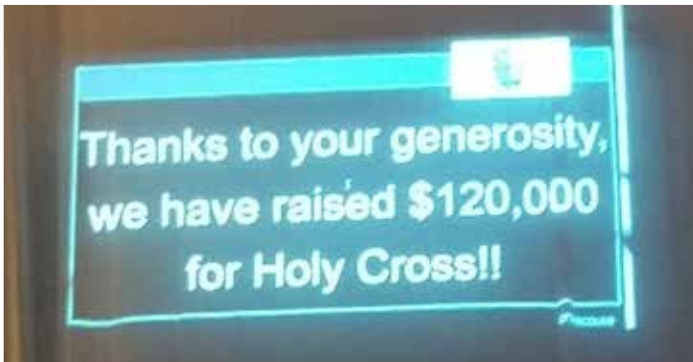

# Adopt-A-Classroom

There are many exciting new things happening at Holy Cross High School. One of the major projects is to completely renovate the original Bishop David part of the school. This "original wing" has not had any major renovations since its construction in the 1960s. This renovation includes new windows, HVAC, new doors, drop ceiling, new lighting and a new PA system. This would enable Holy Cross present and future students to learn and grow in a setting that they deserve. This will change the face of Holy Cross. One of the major funding sources of this portion of the project is the Adopt-A-Classroom campaign. Several of our Bishop David and Holy Cross classes have accepted this challenge!

The cost to adopt-a-classroom is \$15,000. Once the class has completed the challenge a plaque with the "adopter" name will be displayed outside of their chosen classroom.

# Scholarships

Thanks to all those who have donated to the following scholarships. Donors contributed to the scholarship of their choice.



## **The Vaughn Schum Scholarship**

This \$1,000, non-renewable scholarship was established by the family of Vaughn Schum to honor his belief that the three most important things in life are: God, family, and education. He had eleven children all of which whom attended Catholic grade schools and high schools. He believed that children needed certain things in life to be successful and that Catholic Schools help provide opportunity and the knowledge that someone cares. Helping make this education attainable for those who sought it was paramount in his beliefs. Eligible students must have maintained a "C" or above average and must qualify for financial assistance through FACTS.

## **The Chuck Schuler Memorial Scholarship**

This \$1,000, non-renewable scholarship was established by Chuck's family after his unexpected death. Chuck believed in Holy Cross' mission and was an important supporter of the school. He was always in the stands at various sporting events supporting his children (Liz and TJ) as well as all of the other student athletes. Eligible students must be involved in extra-curricular activities or sports at their current school and must qualify for financial assistance through FACTS.

## **January Taylor-Mills Scholarship**

This \$500, non-renewable scholarship is awarded by January Taylor-Mills, (HC'95) to an incoming Freshmen (one boy and one girl) who have completed the

recommendation forms, qualify for financial assistance, and must maintain a "C" average or better.

## **Holy Cross Scholars Merit Award**

This is a \$1,250 renewable, four-year scholarship to one student who makes the Principal's List or Maroon List each quarter and performs 10 hours of service to his or her parish. The student must be a graduate of a Catholic grade school, must take the placement test at Holy Cross, and must receive the highest score on the placement test. Other criteria required.

## **Holy Cross Scholars Merit Award**

This is a \$750 renewable, four-year scholarship awarded by Holy Cross to one recipient who makes the Principal's List or Maroon List each quarter and performs 10 hours of service to his or her parish. The student must be a graduate of a Catholic grade school, must take the placement test at Holy Cross, and must receive the 2nd highest score. Other criteria required.

## **Cougar Scholars Merit Award**

This is a \$500, four-year, renewable scholarship. The scholarship is awarded to four students who make a minimum of the Maroon or Gray List Honor Roll each quarter and perform 10 hours of service to Holy Cross and/or their parish. They must take the placement test at Holy Cross, score an 85% or above, and place third through sixth on the placement test. Other criteria required.

### **Father Duerr Scholarship**

This is a \$500 one-year, non-renewable scholarship awarded to one student. He or she must take the placement test at Holy Cross, must maintain a "C" average and have no failing grades, and must qualify for need-based assistance.

### **Holy Rosary Foundation**

This \$1,000 scholarship is awarded by the Holy Rosary Foundation. This student must maintain a "C" average and qualify for need-based assistance.

### **Michael Beavin Scholarship**

This is a \$1,000 scholarship awarded to one Holy Cross student. The scholarship is non-renewable. Student must qualify for need-based assistance.

### **Tinsley Scholarship**

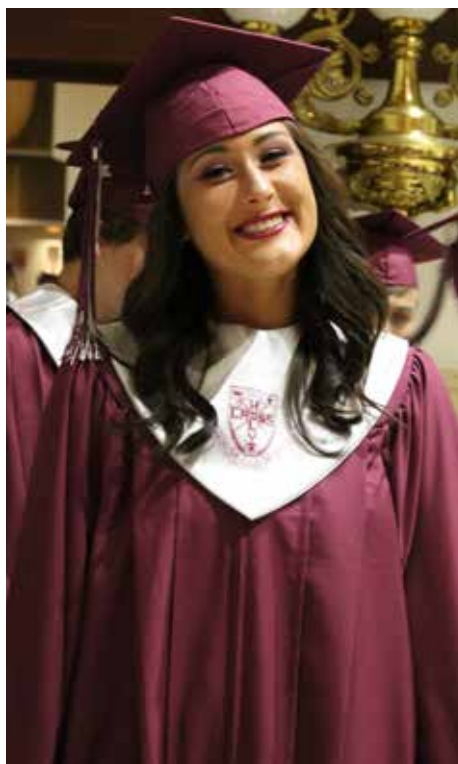
This is a \$240 scholarship awarded to one Holy Cross student. This student must take the placement test at Holy Cross and must qualify for need-based assistance. The scholarship is non-renewable.

### **John L. (Lou) and Frances Ising Scholarship**

This is a \$500 renewable scholarship awarded to one student. He or she must provide service to the community, participate in extra-curricular activities, complete other criteria stipulated by donor, and must qualify for need-based assistance.

### **Chester and Mildred Needy Scholarship**

This \$500 scholarship is awarded to one student who must meet criteria stipulated by the donor and must qualify for need-based assistance.



### **Roy and Gladys Gividen Memorial Scholarship**

This \$250 one-year, non-renewable scholarship is awarded to one student who must meet criteria stipulated by the donor and must qualify for need-based assistance.

### **King Family Memorial Scholarship**

This \$1,000 one-year, non-renewable scholarship is awarded by the King Family to an incoming freshman who has completed the recommendation forms, qualifies for financial assistance, and maintains a "C" average or better.

### **Ursuline Sisters Scholarship**

\$1,000 non-renewable  
The Ursuline Sisters of Louisville, Kentucky, an apostolic religious congregation of the Roman Catholic Church, rooted in the spirit and tradition of St. Angela Merici,

are committed to a life of prayer, community, and participation in the teaching mission of the Church. Rooted deeply within the origins of Holy Cross High School, the Ursuline Sisters were the founders of Angela Merici High School and operated the school until its merger with Bishop David in 1984.

### **Emmaus Award**

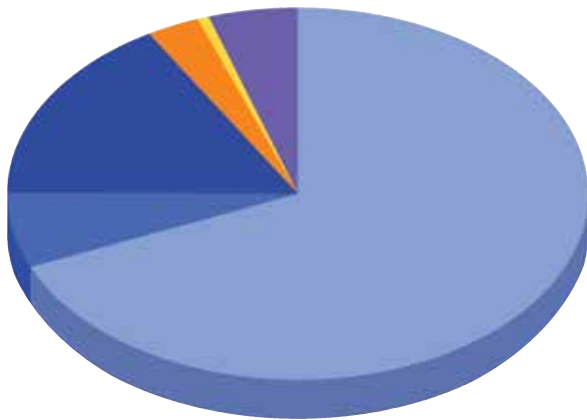
\$500 non-renewable  
The Emmaus story in the Bible describes an encounter with the Risen Jesus. The disciples on the road to Emmaus did not realize the man who accompanied them and spoke with them about scripture was Jesus. This story reminds us that He walks with us, too. The Emmaus Award is presented with the understanding that students on a faith journey need someone to walk with them. The donor of this award will be on a spiritual journey with the recipient as we walk together in Christ.

### **The Andy Kehl Scholarship**

This \$1,000 renewable four year scholarship was established in honor of Andy Kehl, BD'84 because Andy believed a Catholic education provides the foundation for a successful life and that the Holy Cross community is like no other! Andy attended Bishop David and graduated in 1984. Andy was a great father, husband, brother and friend and he credited his Catholic education with being vital to who he was. He passed away in 2015 from a five-year battle with colon cancer.

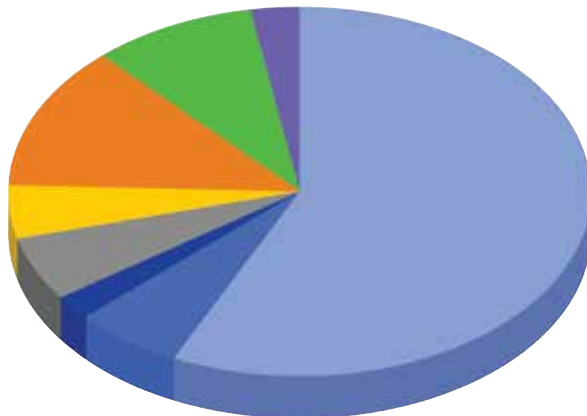

Students at Holy Cross engage in a variety of real-world, authentic experiences to deepen their liberal arts education. Designed to bring together the core components of learning in the classroom with skills development for today's economy, this program gives students a complete educational foundation for success in the rapidly changing world. There are two major components that ensure success of this program: robust curriculum and engaged corporate partners. The Holy Cross High School Corporate Internship Program curriculum focuses on competencies in nine key areas: Technical Skills, Business Etiquette & Ethics, Communication, Complex Reasoning Strategies, Precision & Accuracy, Teamwork & Collaboration, Initiative & Self-Direction, Productivity, Persistence.

All Holy Cross High School students are engaged in the Corporate Internship Program at various levels and all students participate in a Summer Bootcamp Intensive. Freshmen develop basic job-related skills; explore careers; and engage with businesses and professionals in a variety of ways. Sophomores deepen specific career-related skills, serve in the world of non-profit, and participate in the job search process through such activities as resume development and interview skills. Juniors and Seniors continue to deepen their understanding and discernment of a variety of careers through interning one day per week in a corporate environment, developing an understanding of workplace safety, participating in authentic evaluation and assessment of performance, and engaging in mentorship with real-world leaders.

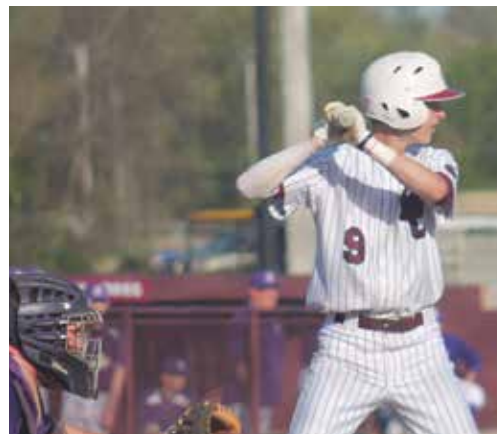
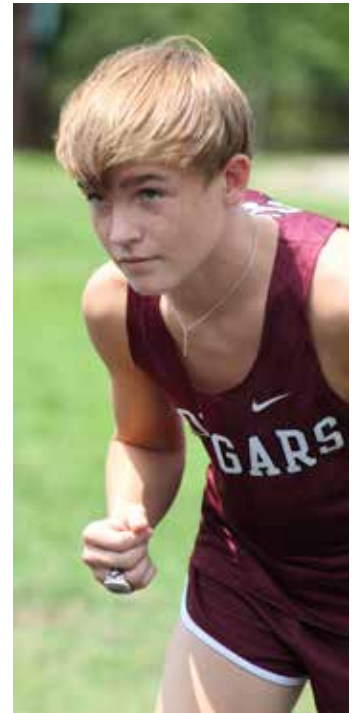
